FOOTPATHS

1 STANSHAWES DRIVE FOOTPATH (FREEHOLD) (Pathway - Title Number AV210197)

This pathway which forms part of the Yate Cycleway Link is owned by the Town Council. The area is also an important wildlife corridor within the Town. There are three litterbins and one dog bin along this pathway.

MEMORIALS

2 MEMORIALS (LYCH-GATE AND PARNALL (Grade II Listed)) (The Parnall War Memorial is unique in that it is a memorial to civilians being contemporaneous)

Yate Town Council has the power to maintain the two War Memorials; the Parnall Memorial situated in St Mary's church yard and the Lych-gate situated at the entrance to St Mary's Church yard.

As part of the Armistice Trail to mark 100 years since the end of WW1 a QR code board, produced in conjunction with St Mary's Church and South Gloucestershire Council, is fixed on the wall to the left of the Lych Gate at St Mary's Church, with links to information about the Lych Gate, Parnall and Commonwealth Grave Memorials at St Mary's Church as well as to information about the former Cottage Hospital.

OPEN SPACES

3 ABBOTSWOOD (FREEHOLD – LAND) (Title Number AV174561)

Land surrounding Abbotswood Shopping Centre, including open space to the front of the shops laid to paving and grass, plus hard-core tarmac access area to rear of shops and one garage. There are three litter bins plus one recycling bin and seven seats, a sign has been attached to one of the seats to designate it a Happy To Chat bench. There is one Town Council noticeboard and a friends notice board on the land in front of the shops, and a Queen Elizabeth II Platinum Jubilee bench in the shopping area. There is also a low level wooden snake play sculpture with 5 wooden steppingstones and some grass matting located on the grassy area to the front of St Nicholas Church and Family Centre, beneath the trees. Solar powered lighting is positioned at the front of the shops. A new play area consisting of a timber rope climbing unit, a timber sculptured ant, boulders with a North, East, South, West dial, a timber snail and timber stepping logs are also to the front of the shops.

In 2021 the latest additions to the site include the installation of new paving, improving access and the aesthetic of the area. Additional natural play equipment has been installed including two bug hotels, a compass seating circle, a multi play unit with slide, a supersize

ant sculpture, a wooden balance trail, a set of 'talking tubes', a ladybug springer and wooden see saw. A defibrillator will be installed in 2023 and will be registered with the "The Circuit" – The National Defibrillator Network.

The freehold reversion to 34 Abbotswood Yate was sold in June 2018. The freehold reversion to 35 Abbotswood Yate was sold in June 2018.

4 LYE FIELD (FREEHOLD) (Land lying east of Goose Green Way - Title Number AV204079)

Open space land situated on the corner of Goose Green Way and Station Road used for informal recreation. Part of the Yate Cycleway Link runs across this land. It contains two seats, one dog bin, three litterbins, two information signs, one noticeboard, a kickabout area and a shelter type seating area.

5 RODFORD FIELD (LAND OFF BARNWOOD ROAD) (LEASE) (Title Number GR354500 AND AV179175)

Open space land situated on land at the former Rodford School site leased from South Gloucestershire Council as from 19 July 2017 for a period of 50 years until 18 July 2067. This site includes one information sign, one kissing gate and one litter bin.

An area of the field has been earmarked for allotments approx. 12 half sized plots and 9 quarter sized plots. An area for car parking is included up to a max of 12 spaces.

6 TYLERS FIELD (FREEHOLD) (Open space north of Gravel Hill road - Title Number GR243045)

Open space with community woodland.

There are three wildlife interpretation boards and a beacon cage. One plaque, two dog bins, three litterbins, two information signs, one noticeboard and three drop bollards.

During 2022 fruit trees and bulbs were planted as part of the Town Council's Local Nature Action Plan (LNAP).

7 WELLINGTON ROAD (FREEHOLD LAND ACQUIRED 20.12.17) (OPEN SPACE OFF CAMBRIAN DRIVE) (Title Number GR219262)

Land situated behind the Church of the Latter Day Saints on Wellington Road and to the side of the Wellington Road Kickabout area. There is a 50 year overage connected to this site. This site has one litter bin.

During 2022 trees and bulbs were planted as part of the Town Councils Local Nature Action Plan (LNAP).

8 WESTERLEIGH ROAD (FREEHOLD)

(From March 2015 - Open space at the junction of Westerleigh Road and Rodford Way – Title Number AV1018)

Grassed open space next to the Witches Hat Play area at the end of Westerleigh Road. This area contains pathways, mature trees, shrubs, one litter bin and three benches.

PARKS

9 BRINSHAM PARK (LEASE) (Title Numbers – GR286891 & GR231475)

Yate Town Council leases Brinsham Park from South Gloucestershire Council on a 50 year lease (from 7 June 2011 to 6 June 2061) at a peppercorn rent. Within the park is a lake including a pier/jetty and a children's play area. The play area contains play equipment, safety surfacing, five seats, one litter bin and one recycling bin. There are two additional items of teenage play equipment outside the fenced children's play area. The park also contains two dog bins, nine litterbins, three recycle bins, eight seats, two picnic tables, a barbeque stand, one notice board and a WWII memorial seat. There is also a dipping platform and two seats at the conservation pond with a sign attached to one of the seats to designate it a Happy to Chat bench. There are five signs around the lake warning of 'Thin Ice' in the Winter. Five seats have been donated by the Friends of Brinsham. A defibrillator will be installed in 2023 and will be registered with the "The Circuit" – The National Defibrillator Network. The park remains open to pedestrians at all times.

A running route including x 5 posts with markers attached is around the large field.

During 2022 the following were planted; an Oak Tree in conjunction with our Twinning Association, a fruit orchard for the Queen's Jubilee and trees and bulbs as part of the Town Councils Local Nature Action Plan (LNAP).

10 KINGSGATE PARK (LEASE)

(Title Number GR274501) (Sq. meterage: toilet block 24m2 storage depot 37m2)

Yate Town Council leases Kingsgate Park from South Gloucestershire Council on a 50 year lease (from 1 April 2003 to 29 March 2053) at a peppercorn rent. Within the park are public toilets upgraded in March 2019; these include two unisex cubicles, one disabled cubicle which also includes a baby changing unit and a staff toilet in the service corridor. There is a storage building (this refers to workshops) used by the Estates Staff, twelve lighting columns (thirteen lanterns) installed in 2016, two lakes, a conservation area and two children's play areas. There are 5 signs around the lake areas warning of 'Thin Ice' in the

Winter and there are two 'Dogs on Lead' signs in the Nature Reserve area. The play area contains natural adventure play equipment (including an aerial runway), safety surfacing, six seats, five picnic benches and six litter bins with basketball/kickabout area, three shelter type seats and six information signs. (NB: The play area is being refurbished in 2023) There is a further area containing a water feature which is used by young people as a play area during the summer months. The wider park area also contains five dog bins, thirteen litterbins, one recycle bin, eighteen seats, one picnic bench, one memorial bench, one notice board and one x 3 compartment recycle bin. A sign has been attached to one of the seats to designate it a Happy to Chat bench There is also a totem pole at this site. In 2020 an outdoor gym was installed, and a defibrillator was installed by the Elmwood entrance and registered with "The Circuit" – The National Defibrillator Network.

The Friends of Kingsgate Park have installed a bug hotel, also donated a Steel Red bench and two interpretation boards (one to identify lake birds and one for tree identification). A decorative tree carving seat is in progress as of April 2023 to mark the Coronation of King Charles III.

Events are held annually in the park which include: an Easter Egg Hunt, a Music Festival, known as Yate Rocks! Picnic in the Park and a Christmas Carol event. These events are manned by Friends, volunteers and Town Council staff. Each of these events can attract up to approximately 5,000 people.

The following agreements are currently in place for Kingsgate Park:

Catering Concession Contract with Tony Licata to sell Ice Cream 1 July 2022 – 30 June 2023.

The gate that leads to the Vintage Birdcage Limited is unlocked/locked by them in line with their opening hours.

11 TYNDALE PARK (LEASE) (Title Number – GR334097)

1.347 acres are leased from South Gloucestershire Council on a fifty year lease from 25 March 2000 at a peppercorn rent. The area contains play equipment and safety surfacing (updated in 2014), two information signs, two seats, a picnic bench, three litterbins and a specifically designed decorative gate.

PLAY AREAS

12 HOWARD LEWIS PARK (FREEHOLD) (Title Number – AV229474)

> The Town Council owns the play area and tennis courts currently used as a kickabout area. There are six floodlights, but these are currently disconnected.

The area contains play equipment (upgraded in 2020) with safety surfacing, four seats, one litter bin, one recycle bin and one information sign.

An area of unused land, which had been fenced off for some years, was sold in January 2019.

13 LONGS DRIVE PLAYZONE (LICENCE)

Yate Town Council acquired open space land at Longs Drive on a 50 year licence from South Gloucestershire Council commencing 3 January 2012 to 2 January 2062. There is teenage seating and play equipment on this piece of land. There are also two dog bins, one litter bin and one information sign on this site.

14 MILLSIDE PLAYZONE (LEASE)

(Millside Play zone - Title Number GR3332015) (Land at Randolph Avenue - Title Number GR286891 excluding Title Number GR363099 adopted highway)

Leased from South Gloucestershire Council 50 years from 1 October 1997 to 30 September 2047 rent free. Contains children's play equipment (upgraded in 2021 & 2022) including an aerial runway, one information sign, three litter bins, one recycling bin, five picnic tables and six seats.

Adjacent to this is an area known as Millside open space (Randolph Avenue). This area of land is leased to Yate Town Council from South Gloucestershire Council on a 50 year lease from 3 January 2012 – to January 2062 and contains two litter bins, two dog bins and a wooden decorative entrance. There are three bug hotels and eight sculptures. There is also a wetland habitat at this site. Two interpretation boards have been installed. The park remains open to pedestrians at all times.

During 2022 fruit trees, native trees and bulbs were planted as part of the Town Council's Local Nature Action Plan (LNAP). The Town Council also received trees donated by SGC that are currently maintained by SGC but owned by Yate Town Council.

15 PEG HILL SKATE PARK (FREEHOLD) (Title Number – GR236553)

A park situated at the top of Peg Hill containing a skatepark of concrete bowls, a street course and static ramps. The park also contains four litter bins, one recycle bin, one dog bin and three information signs. This site has nine dedicated lights which come on at dusk and go off at 8pm. The site also benefits from six streetlights.

During 2022 bulbs were planted as part of the Town Council's Local Nature Action Plan (LNAP).

16 ST MARY'S PLAY AREA (LEASE) (Title Number – GR287183)

An area of land adjacent to St Mary's School providing two play areas, one for older children and one for children eight and under. This land is leased from South Gloucestershire Council on a twenty five year lease from 1 December 2003 to 31 November 2028 at a peppercorn rent.

The areas contain play equipment (refurbished in 2016) and safety surfacing, three seats, one litter bin, one recycling bin and two information signs.

17 WELLINGTON ROAD KICKABOUT AREA (LICENCE) (until determined)

This land is currently licenced from South Gloucestershire Council, commenced 1 May 2005 and shall run until either party gives three months' notice in writing at any time, with no fee payable. Contains one information sign, two teenage shelters, five litter bins, three seats, four dog bins and a kickabout area.

18 WITCHES HAT - WESTERLEIGH ROAD PLAY AREA (LEASE) (Title Number – GR289091)

0.6 hectares of land used as a children's play area leased from South Gloucestershire Council on a 10 year lease from 1 October 2005 to 30 September 2015 at a peppercorn rent. Negotiations are ongoing to renew the lease with South Gloucestershire Council who have agreed a renewal will be granted.

The area was refurbished in 2015 and opened on 1st May 2015, with new sandpit, timber climber/bridge/slide, basket swings, rock/rope/timber trail, mini witches hat, teenage seating and extended woodchip pit. A new skate park area opened on 22 May 2015 with new concrete skate ramps, graffiti wall with wooden shelter over it, bitmac base, one litter bin, two wooden 'skateboard' benches, rope's structure, new paths, witches hat and trampoline, safety surfacing, three seats, two litter bins, two information signs and one picnic table. The site is fenced with 1.8m high plastic coated welded mesh fence with two wheelchair accessible pedestrian gates and one 4m wide access gate. The park remains open to pedestrians at all times.

19 YATE WEST KICKABOUT (LICENCE)

This land forms part of the Playing Fields at Tyndale Primary School in Cranleigh Court Road. There is a licence in place with South Gloucestershire Council for the use of this land which commenced 18 July 2007 and runs for 20 years until July 2027. The fee is £1 per annum. The kickabout area contains one sign, one litter bin, fencing and one noticeboard. This site is used by the adjacent school during school hours and is open to the general public after school hours, at weekends and during school holidays.

PROPERTIES

20 ARMADILLO YATE YOUTH VENUE AND CAFÉ, STATION ROAD, BS37 4FW (FREEHOLD) (Title Number – GR345038) (Sq. meterage: ground floor 335m2, first floor 196m2)

This building houses a café provision for young people along with a cinema, plus rooms to let on a casual basis when the café is not in use by the young people. This venue is also used as a community café/cinema on a Saturday morning and is used as a senior citizens cinema club on a Thursday. Off the Record regularly hire rooms and provide a weekly Health and Wellbeing Hub session on a Wednesday afternoon.

The garden area consists of three circular seating pods, two seating shelters with outdoor beanbags and cushions and a large, paved patio area with a wooden rectangular table, chairs, benches and a Thermo Composting Box. Sports equipment consists of basketball, badminton and football nets along with swing-ball and volleyball equipment. Artwork is fixed to the external wall of the building.

The Armadillo (building and land) freehold was transferred in its entirety from South Gloucestershire Council to Yate Town Council on 8 April 2015.

The Armadillo must remain as community use until April 2045 in the first instance, in line with the conditions of the transfer of ownership to Yate Town Council.

A defibrillator was installed by the main entrance in February 2020 and is registered with "The Circuit" – The National Defibrillator Network.

21 EGGSHILL LANE/STATION ROAD HALLS, 100 - 104 STATION ROAD, BS37 4PQ (FREEHOLD)

(Land containing Parish Hall, Community Association and land at the back of the YMCA Title Number GR332545) (Sq. meterage: Parish Hall 207m2) (Land containing YMCA Title number GR332911) (Sq. meterage: floor area 113.04sqm) (Play Area - Title Number GE332542)

This comprises the site of the Parish Hall, site of the Yate Community Centre, site of the YMCA and land at the rear used as children's grassed play area.

The Parish Hall appears on the 'Local List of Buildings of Interest.' It comprises of a main hall, committee room, kitchen, toilets and storeroom; it is hired out to local groups and organisations. A notice board is located at the front of the station road halls and car parking is available at the front and sides of the building. A defibrillator has also been installed and is registered with "The Circuit" – The National Defibrillator Network.

Yate Men's Shed have a lease in place to use the committee room within the Parish Hall for three years 6 months from 1 September 2021 until 31 March 2025.

The Community Centre site is let on a 99 year lease from 1 October 1965 at a fixed annual ground rent.

A small area to the rear of the YMCA building is also contained within this title number.

The YMCA building in Station Road, acquired by Yate Town Council on 19 December 2018 and is hired out to local groups and organisations. The building includes a kitchen (upgraded in 2021) and toilets. The garden area includes one picnic table, one Queen Elizabeth II Platinum Jubilee bench, two hexagon planters and two raised flower beds. There is also a small outbuilding for storage. In 2022, fencing was extended around the garden area with a gate installed leading to Eggshill play area.

The children's play area at Eggshill Lane comprises grassed area, play equipment with safety surfacing, three seats, one litter bin and one information sign.

POOLE COURT, POOLE COURT DRIVE, BS37 5PP (FREEHOLD) (Title Numbers – AV179319 & AV224015) (Sq. meterage: ground floor 267.5m2, first floor 238m2, second floor 120m2)

The Town Council owns Poole Court. The property appears on the 'Local List of Buildings of Interest'. The building is used for Town Council Offices and provides accommodation for meetings, functions and weddings. Rooms are let on a casual basis to local groups and organisations. There is a resident caretaker.

South Glos Parent Carers CIC currently lease a room at Poole Court on a 3 year lease from 1 April 2022 to 31 March 2025. A room is provided, on an ongoing arrangement, to Family Food 4 Free to act as a Community Fridge which is managed and run by volunteers.

The grounds at Poole Court include approximately half the pathway from Poole Court to Newman's Mound. There are two litter bins, a Thermo Composting Box and two seats in the Poole Court grounds and one dog bin along the pathway. There is one notice board, one information sign, a salt bin, one flagpole, two hexagon planters, an entrance sign and a vehicle dual charging point. There are five car park solar lighting columns including one double light head unit. A defibrillator was installed in 2020 on the external wall near the disabled entrance and is registered with "The Circuit" – The National Defibrillator Network. There are eight dedicated trees in the grounds including one to mark the council's commitment to Carbon Net Zero by 2030 and one to honour the local community heroes who committed their time during the Covid-19 pandemic. A bike store is located to the side of the building. Poole Court also houses a funeral bier and a litte picking board which is let on short term loan to various community groups.

23 POP INN CAFÉ, WEST WALK, BS37 4AX (LAND LEASE) (Title Number – GR247112) (Sq. meterage: 110m2) The Pop Inn Café for the over 50s is situated next to the Library in West Walk in Yate Shopping Centre. This building is constructed on land owned by South Gloucestershire Council, which is leased by Yate Town Council for a 25 year period from 17 December 2001 to 16 December 2026. The Pop Inn Café is operated with the assistance of volunteers and is let out of café hours on a casual basis. There is one Town Council notice board outside the property.

24 YATE HERITAGE CENTRE, CHURCH ROAD, BS37 5BG (FREEHOLD) (Heritage Centre - Title Number AV285803) (Sq. meterage: 85m2)

Yate Heritage Centre is situated on Station Road and was purchased in February 1998. This building was fully restored to provide a Heritage Centre for Yate. An Air Source Heat Pump was installed in 2023. The Heritage Centre provides many events throughout the year including the annual St George's celebration event, International Day and Heritage Open Sunday events. The events are manned by volunteers and Town Council staff. The Heritage Centre is operated with the assistance of volunteers. Children's workshop events are also held at this location during the school holidays.

There is one noticeboard at this site located near the entrance and one car parking sign. A defibrillator has also been installed and is registered with "The Circuit" – The National Defibrillator Network.

As part of the Armistice Trail to mark 100 years since the end of WW1 a QR code board produced in conjunction with St Mary's Church and South Gloucestershire Council, is fixed on the wall inside the Heritage Centre, with links to information about the Lych Gate, Parnall and Commonwealth Grave Memorials at St Mary's Church as well as to information about the former Cottage Hospital.

SPORTS FACILITES

25 BROAD LANE (YOSC) (FREEHOLD) (Title Number – GR325823) (Sq. meterage: clubhouse 347m2, shower block B 205m2, shower block C 236m2, workshop 270m2)

The Town Council owns 16.42 acres of land at Broad Lane which forms part of the Yate Outdoor Complex Sports dual use facility.

The Town Council owns an all-weather pitch, and car park on the site. It also owns the main accessway to the site which is floodlit. The all-weather pitch and grassed athletic field event training area are both floodlit. There are also pitches for football and rugby.

The all-weather floodlit running track is incorporated within the complex, partially constructed on Town Council land and partially on South Gloucestershire Council land and includes 2 long jump pits, a pole vault area, 2 shot circles and 2 throw cages.

Yate Town Council has a lease with South Gloucestershire Council for the remainder of the land which runs until 31 October 2065 (50 years) at a peppercorn rent. A Transfer of Control Agreement between Yate Town Council, South Gloucestershire Council and Brinsham Green School detailing community use/school use of land and facilities runs for 5 years until 23 July 2023.

The site is managed by a charitable company limited by guarantee and run by volunteers.

The site comprises of a Clubhouse, including a Community Function Suite which incorporates a meeting room and functional lounge with a licensed bar as well as a kitchen for hire, a Changing Block and an Admin and Changing Block. There is a Welcome sign and one Yate Town Council noticeboard on the wall as you approach the clubhouse entrance.

There is a metal shed on the site for storage, and two converted containers allow site users, such as Yate Rugby and Yate Football to store their equipment.

Disability equipment purchased and owned by Yate Town Council has been provided to YOSC Ltd on long term loan. This is to allow access to all hirers / users of the YOSC site, with additional needs to undertake sport, to benefit from the equipment.

A Multi Use Activity Building has been built on this site and was made available from 2021. This building is used to provide indoor sports facilities (excluding ball games) and is equipped with multiuse equipment.

A Target Sprint Structure owned and built by YOSC Ltd with permission from Yate Town Council is present on site.

26 SUNNYSIDE PLAYING FIELD (FREEHOLD)

(Title Number – GR333270) (Sq. meterage: bowling green pavilion 124m2, workshop 83m2, football pavilion 141m2)

This area comprises land currently in use as tennis courts, a bowling green and one principal football pitch. It includes a bowling pavilion and football changing rooms. Adjoining the bowling pavilion is the estates staff workshop, garage and compound. Car parking is available. A turning 'hammer head' exists at the end of Sunnyside Lane, hatched in yellow.

The bowling pavilion and the bowling green are let on a 6 monthly licence to the Yate and District Bowling Club. (Current licence period 1 April 2023 – 30 September 2023)

There are two seats, three litter bins, one recycle bin, one dog bin, a notice board (adjacent to the bowling green) and two information signs on the Sunnyside playing field, seven seats and one litter bin within the bowling green, two seats and two litter bins within the tennis courts and three litter bins, one dog bin on the Common playing field and tree galvanised

cycle hoops. A defibrillator was installed on the front wall of the bowling pavilion in 2020 and is registered with "The Circuit" – The National Defibrillator Network.

A football pavilion serves the principal pitch on Sunnyside Playing Field and the three pitches on The Common, all of which are let to football clubs during the season. It was refurbished in 2018 to include women's and disabled changing rooms and has the added value of solar panels installed.

The tennis courts were re-surfaced and re-fenced in autumn 2014.

27 YATE COMMON FOOTBALL PITCHES (LEASE) (Title Number – GR331976)

The Town Council provides three football pitches on Yate Common, let to various football clubs during the season. Leased from South Gloucestershire Council for 28 years from 1 October 1994 to 30 September 2022 at a peppercorn rent if demanded. Negotiations are ongoing to renew the lease with South Gloucestershire Council. The Yate Common pitches contain one dog bin and two litter bins.

A running route including x 9 posts with markers attached is placed around the football playing field.

Permission was granted in March 2023 by South Gloucestershire Council for Yate Town Council to plant and maintain 25 Fruit Trees in the Northeast section of the Common to act as a COVID-19 memorial garden.

VILLAGE GREENS

28 GOOSE GREEN (FREEHOLD) (VILLAGE GREEN STATUS) (Title Number – AV188091)

The Town Council owns the green area of land at Goose Green. There are two dog bins in this area, one litter bin, one seat and two signs. (Registered as village green: Village Green Number GVG5)

29 ST MARY'S GREEN (FREEHOLD) (VILLAGE GREEN STATUS) (Car Park at St Mary's – Title Number AV241866) (Village Green to the side of the Heritage Centre – Title Number GR202316) (Green area of land known as St Mary's Green adjacent to Church Road – Title Number AV188090)

The Town Council owns the green area of land known as St Mary's Green adjacent to Church Road together with the access road to the church and most of the car park (all of which is registered as village green: Village Green Number GVG194); there is one recycling bin (donated by McDonalds) and one litter bin on this area (one in the car park and one on the green), one dog bin, two seats, one memorial bench, one steel planter and one information sign. Bollards owned by St Mary's CE Primary School have been installed at the entrance to the car park with permission from the Town Council.

A sign has been attached to one of the seats to designate it a Happy to Chat bench. There is a peace rose garden. There is an additional grassed area to the side of the Heritage Centre surrounded on three sides by Cotswold stone walling (registered as village green: Village Green Number VG 198), this has also been registered as part of the Green. The annual St Georges Day and International Day events held by the Heritage Centre also make use of this space. Each of these events can attract up to approximately 1,500 people.

30 VERGES ADJACENT TO THE LAWNS INN, CHURCH ROAD. (FREEHOLD) (VILLAGE GREEN STATUS) (Title Number – AV241866)

The Town Council owns a section of the verge in Church Road adjacent to the Lawns Inn public house. (Village green reference G/VG30)

31 YATE ROCKS (FREEHOLD) (VILLAGE GREEN STATUS) (Title Number – AV188092)

The Town Council owns the green area of land at Yate Rocks: there is one seat on the green.

- 36 i Various Wayleave Agreements are in existence in relation to land owned by the Town Council.
 - ii Highway Authority consent exists for the planting of an Oak Tree to the front of Grace Church Yate.
 - iii The Town Council also has Notice Boards besides those previously listed on Wellington Road opposite the Farmhouse Pub and at Ladden Garden. There are also five Heritage Boards located around the town; Yate Railway Station, Yate Library, Cranleigh Court Road (Tyndale/Sure Start), Brinsham Fields and Kingsgate Park.
 - iv The Town Council also has a defibrillator besides those previously listed adjacent to the Westerleigh Road roundabout, near the 'Road to No Where'. This will be installed in 2023 and registered with "The Circuit" The National Defibrillator Network.

- v The Town Council undertakes annual spring cleans and other ad hoc community events which include volunteers.
- vi Yate Common is owned by South Gloucestershire Council. South Gloucestershire Council funded works undertaken on the Common by Yate Town Council in consultation with the Friends of Yate Common (volunteers) to the end of March 2013.
- vii The Town Council holds various other Civic Events besides those previously mentioned including the annual Civic Service, the annual Remembrance Service and the Volunteer Christmas and Grants Presentation evening. Events also take place when hosting the twinning exchange with Yate's twin town of Bad Salzdetfurth.
- viii The Town Council commissioned the Wellingtonia Tree Wood Sculpture, completed in February 2018, and Interpretation Board, completed in July 2019, with permission from South Gloucestershire Council. It is located on a small triangle of grassed open space adjacent to the traffic lights at the crossing on Station Road and Broadway.
- ix In 1995 the Town Council commissioned the Yate Town Coat of Arms Mural to be located on the wall next to McDonalds in the Yate Shopping Centre (approx. size 1.8m x 3.6m).
- x A raised flower bed on the junction of Station Road and Cranleigh Court Road owned by South Gloucestershire Council is maintained by the Town Council. The Town Council own and maintain 9 planters at various locations along station road.
