1.4. Sunnyside Bowling Facility

To **NOTE** that further to minute 79.4 of the Full Council meeting held on 10 January 2023, Yate & District Bowling Club has accepted the offer of a six-month licence at a cost of £15,165 for the 2023 season. They have expressed their gratitude to the Members and staff of Yate Town Council for all they do for the Bowls club and are relieved and pleased that the licence fee will remain at last year's figure.

In accordance with item 5.1 of the Licence, to sell alcohol at Sunnyside Pavilion, Yate & District Bowling Club has submitted a written request for permission for council to consider.

1.5. Annual Rent/Price Review

Further to the Yate Town Council Lettings & Pricing Policy, annual rents outside of a valuation year are to be increased and applied annually by officers in line with Septembers RPI which is 12.6%. Owing to the current cost of living crisis officers have drafted the 2023/2024 annual rent reviews with a broad increase of only 4%, as per income figures agreed within the 2023/2024 Budget by Full Council on 10 January 2023, for members to receive and consider. 1.6. Banking Arrangements

To receive and consider the request from Ladden Garden Village Community Group to act as bankers as a short-term measure while banking arrangements for the group are organised. We previously acted as bankers for the group while they arranged their own account, but they are now in a position where they are switching providers and require an account to receive grant funding.

a) Terms of Reference Amendment

It was **RECOMMENDED** that the existing Terms of Reference be permanently amended so that it reads as follows:

TOIL - delegated powers be granted to the Clerk to pay any member of staff, at the employee's request, for TOIL hours accrued, if number of hours exceeds ability to reasonably take the hours without a negative effect on service delivery., (providing within budget), on the proviso that parameters are set around work/life balance and working time. (NB: there is no obligation for an employee to be paid for time worked if they'd rather have the time back in lieu).

b) Action Plan - Local Council Award Scheme

The action plan for 22/23 was considered, along with updates to inform draft 23/24 action plan and Members **RECOMMENDED** that an application to the Local Council Award Scheme not be pursued at this time as delivery on the ground for the community takes precedent.
