We would like to know what local residents and park users think of the amended design and would be very grateful if you could answer a few questions on the back page of this leaflet.


The Town Council is also considering updating the kickabout goal on Lye Field and would like to know which of the proposed designs you prefer.

Design Notes

Hard surface of the tennis courts retained. New fencing erected to accommodate 5 a-side pitch and basketball. Multi goal units installed at each end, with climbing wall to western edge (grips to outside). Existing lighting removed.

New toddler equipment installed to south west corner of site (refurbished from stored equipment). Play trail, boulders and low timber walls provide incidental play.

New central grass area has seating bays around, which could have scented planting set between bays.

NB existing path to redundant entrance removed.
