## ***Fishing in Kingsgate Park***

Following a previous consultation with residents , Yate Town Council decided to permit fishing at Brinsham Park and keep Kingsgate Park as a dedicated Nature Reserve.

Three members of the public who would like fishing permitted on the lake nearest to Scott Way entrance to Kingsgate Park, have asked the Council to do another survey to see if your views have changed.

Whatever happens, the fishing ban on the main ornamental circular lake will remain.

**Please help us decide whether to change the decision to have fishing at Brinsham and keep the lakes at Kingsgate Park free from fishing, as a dedicated wildlife area.**
